On Sunday our confirmation class and mentors will meet together for the first time. Confirmation is an opportunity for youth to decide for themselves (to confirm) the promises that their parents or guardians made on their behalf at baptism. During the Rite of Confirmation the confirmands will be asked to affirm their baptism into the faith and family of Jesus Christ, and promise to grow in their Christian faith and further Christ's mission in the world.

We have two confirmands: Ryan Cardon and Savanah Bibbs. Each of our confirmands has been assigned a mentor. Ryan's mentor is Richard Sandage and Savannah's mentor is Susan Freepartner. The confirmands, mentors and I will meet after church in the choir room on the second and fourth Sundays of each month. One week will be a confirmation class with me and the other week will be a time for completing their Mentor Program. The Mentor Program has seven sessions (they need to complete six sessions). Each session includes a written assignment to be completed in their confirmation journal. They are also required to participate in six community service projects. In addition, they will lead worship with me in February and again in May.

On Pentecost, Sunday, May 31 we will confirm these two young adults. Once confirmed they are considered full members of Lynnhurst United Church of Christ with the same rights, responsibilities and voting privileges as our adult members.

Please welcome and encourage Savannah and Ryan - they are our next generation of church leaders. Also, please pray for them and their mentors.

Write a Letter to Congress Advocating to Help Migrant Families: Each day brings a new attack on our immigrant neighbors and the scope and breadth of these challenges can be staggering. Congregations communities across the country are asking what can be done to help the migrant families and children being held in immigrant detention. We see children sleeping on concrete floors, parents grieving after being cruelly separated from their children, overcrowding and lack of even basic humanitarian conditions in detention facilities. As the United Church of Christ we have declared ourselves to be an immigrant welcoming church, believing that love of our neighbor extends to welcoming each migrant— and that compassion should be at the root of how our nation treats migrants.

How we invest our money reflects our values as a nation, and right now those values are corrosive and harmful. policies that uplift family unity, address the root causes of Indiana-Kentucky Conference office at forced migration, and prioritize human needs by respecting the rights and dignity of every person.

> This experience has been a nightmare for her and her children. Housing insecurity is a public health issue, and she has multiple health problems related to these evictions. But Shemaeka Shaw does not need prayers, sympathy, a rentereducation program, a landlord-incentive program or a financial-literacy class. She needs policies that protect her and her community from an oppressive and predatory process.
